

Privacy Policy

ANIMIC Project (the “Project”) sets forth this Privacy Policy (this “Policy”) with regard to the treatment of users’ information, including but not limited to personal information, during the performance of services provided by the Project (the “Services”), as follows;

1 Information Collection and Use

For a better experience, the Project uses third party services that may collect information used to identify you.

2 Log Data

Whenever you use the Project, in a case of an error in the app the Project collects data and information (through third party products) on your phone called Log Data. This Log Data may include information such as your device Internet Protocol (“IP”) address, device name, operating system version, the configuration of the app when utilizing my Service, the time and date of your use of the Service, and other statistics.

3 Cookies

Cookies are files with a small amount of data that are commonly used as anonymous unique identifiers. These are sent to your browser from the websites that you visit and are stored on your device's internal memory.
